These fees are estimates only for students enrolling in government funded courses in 2019 on a full time basis.

The indicative fees for a course may differ between training providers due to the units they have included in the course outline. These differences generally result from adapting courses to meet local industry needs.

Concessions and annual course fee caps may also apply to some courses. Fee caps are only shown on the basis that all units are commenced in 2019. Fee caps apply to some tuition fees only. For secondary school aged persons (in 2019, students born on or after 1 July 2001 who are at least 15 years old) undertaking training that is not part of a VET in Schools program, the maximum course fee chargeable in 2019 is \$420 plus the resource fees and discretionary fees.

Fees have been quoted on the basis of 2019 fee rates only. These are expected to change in 2020. Other charges may apply.

In some instances the fees for a course may contain units from the next lower level, if you have already completed those units in the lower level, your fees will be less.

In some instances a course may allow direct entry, but have required units that are included in the next lower level which are not included in the displayed fees. If you have not already completed those units in the lower level, your fees will be higher

The student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as student service and resource fees.
